You must be 21 years old or older to sign this document. The cost of shipping, the kennel crate and health certificate is extra, and the responsibility of the purchaser. We guarantee our puppies for two year for hip and elbow dysphasia and eye entroply. If you have a problem, we require a copy of a vet exam and explanation sheet. We also have the option of a second opinion. We have 180 days to replace a puppy due to genetics stated above, or death due to genetics from the date of your vet's examination.

We do not give refunds at all, and we do not pay your vet bill under any circumstances. If you believe your dog is sick within the first 48 hours and you return the puppy to us, we will return the puppy to you well or replace the puppy. The cost of shipping is your responsibility of the purchaser. The U.S.D.A. requires all puppies be at least eight weeks old before shipping. If balance is not paid in full when the puppy reaches eight weeks old, all deposits will be forfeited and all sales null and void. Our dogs can't be resold, or go to a shelter, rescue or other animal facility it must come back to us good health.

We will furnish a copy of the sire and dam's registration papers along with the registration paper for the puppy. We will also furnish a complete shot record and medication sheet for any medicine or shots given to your puppy. We are not responsible for any person or animal bitten or hurt by the animals we sell. The training and behavior of animals after we sell and transfer ownership, is the responsibility of the new owner.

The Old Red English Bulldogs Kennel Inc. doesn't sell, train, buy or breed dogs for any illegal purposes. We want update on all our puppies & dogs when they are going out to the buyer. We will like to see Picture, DVD and also come to your house. If the dog has any marks on them we are going to take them back. We need State Pictures ID from all our buyer or seller.

Purchaser agrees to neuter/spay the puppy before it reaches one year of age. Purchaser agrees to supply Seller with a veterinarian's letter by certified mail as proof of a neuter/spay. If Purchaser fails to neuter/spay this puppy and provide proof to the Seller by one year of age, rights and ownership of the dog will automatically terminate and revert back to Seller who may immediately assume possession of the dog. Seller's reasonable attorney's fees for recovery of the dog will be paid by the Purchaser.

It is understood by all parties to this agreement that this puppy of the above specified description is of pet quality. Purchaser acknowledges and agrees that this puppy will be registered by limited registration. In the event that the Purchaser does not have the puppy properly neutered/spayed, any offspring issuing from this pet-quality puppy are not eligible for registration with the AKC, or OREBA.

When to spay/neuter: Generally this should be done when the puppy has reached at least 5-6 months for a female and 6-8 months for a male. The older the dog, the more able it will be to withstand the anesthesia. There is no need to wait for a female to have her first heat cycle before she is spayed. In fact, you can avoid the problems associated with estrus by spaying her before it occurs. There is also no need to wait for the male to become sexually mature.

Why spay/neuter: Fixing your dog prevents pregnancy and the birth of unwanted puppies. It avoids the need to restrain the dog during estrus. It keeps both sexes from roaming away from your house in search of a mate. It reduces the tendency of male dogs to urinate in the house, marking his territory. Licensing fees are also cheaper. Additionally, it avoids reproductive-related problems such as tumors, pyometra, false pregnancy, prostate infections, and old-age cancers. For you also don't destroy our bloodlines.

Why should *this* dog be spayed/neutered? Any puppy sold as a pet should not be bred. This is simply for the improvement and maintenance of the breeding line for Bulldogs Bandogs, Bandogs, Bandogges, Bulldogges or Mastiffs. Breeders have striven for years to select and perfect the working ability of Bulldogs, Bandogs, Bandogges, Bulldogges or Mastiffs. They are bred not only for their high-energy levels, but their responsiveness and intelligence (which is why they have been noted as the most intelligent breed of dogs). Working Bulldogs, Bandogs, Bandogges, Bulldogges or Mastiffs have no physical AKC or OREBA-like standards with respect to color, height, etc. They are selected purely for their working abilities. Dogs are eligible for a breeding program only if they are able to reproduce either their own quality or better quality in each successive generation. Breeding is not to be done casually nor is it a money-making venture. It is not a hobby and is very time consuming and energy demanding. By demanding that this pet-quality puppy be neutered/spayed, it avoids mass-production of average quality Bulldogs, Bandogs, Bandogges, Bulldogges or Mastiffs, controls the already overblown dog population, and improves the overall fitness of the purebred

This does not mean that this puppy is an inferior dog. This puppy is as capable as any of its littermates of becoming a lovable, well-trained, and perfectly happy dog. This puppy has been tested for its working abilities by exposure to Weight Pulling, Hog Hunting, or Personal Protection and the administration of a modified of any Working " ASSOCIATION" and evaluated for buyer placement by the administration of a Puppy Aptitude Test (PAT). This puppy's test results have simply indicated that it is better suited for pet placement than it would be for Working Dogs trials or any training type.

Any Working Dogs instinct is vital for breeding lines but not for household pets. This does not mean that this puppy will not be able to Work. At this early age it is very difficult to predict with certainty the potential working ability of any pup. Given the proper amount of love and attention, nothing should prevent this puppy from becoming an excellent companion and family member.
